Intended use: The dynamic foot lift orthosis AFO1 Glide, AFO1 FreeFlow, AFO1 Swift System, AFO1 HelixBand, and the Sstep are medical devices to support the dorsi- and plantar- flexor muscle weakness. The devices are intended to lift the foot during swing phase to reduce drop-foot and the risk of catching the toe in mid-swing. The use of carbon fibre in the Glide, FreeFlow, and Swift ankle orthoses provides energy return throughout the phases of gait improving the individual's overall functionality. They are also used to correct foot position during stance in up to 3 planes.
